“These phages were isolated by enrichment of bee debris samples gathered from beehives in Utah using field isolates *Brevibacillus laterosporus*”. *Brevibacillus* phages Jenst and SecTim467 have short (359 bp) direct terminal repeats. BLASTN and CoreGenes (Table 1) [2], and phylogenetic analyses (Fig. 2) [3] all indicate that the proposed genus, *Jenstvirus*, is cohesive and distinct from other genera.

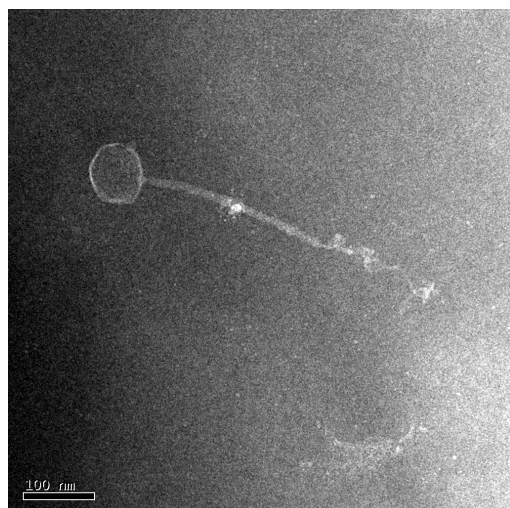

**Fig. 2.** Phylogenetic analysis of the large subunit terminase proteins of jenviruses and related phages constructed using “one click” at phylogeny.fr [3]. "The "One Click mode" targets users that do not wish to deal with program and parameter selection. By default, the pipeline is already set up to run and connect programs recognized for their accuracy and speed (MUSCLE for multiple alignment and PhyML for phylogeny) to reconstruct a robust phylogenetic tree from a set of sequences." It also includes the use of Gblocks to eliminate poorly aligned positions and divergent regions. "The usual bootstrapping procedure is replaced by a new confidence index that is much faster to compute. See: Anisimova M., Gascuel O.
